The Skills Centre is committed to achieving Net Zero emissions by 2050.

Baseline Emissions Footprint

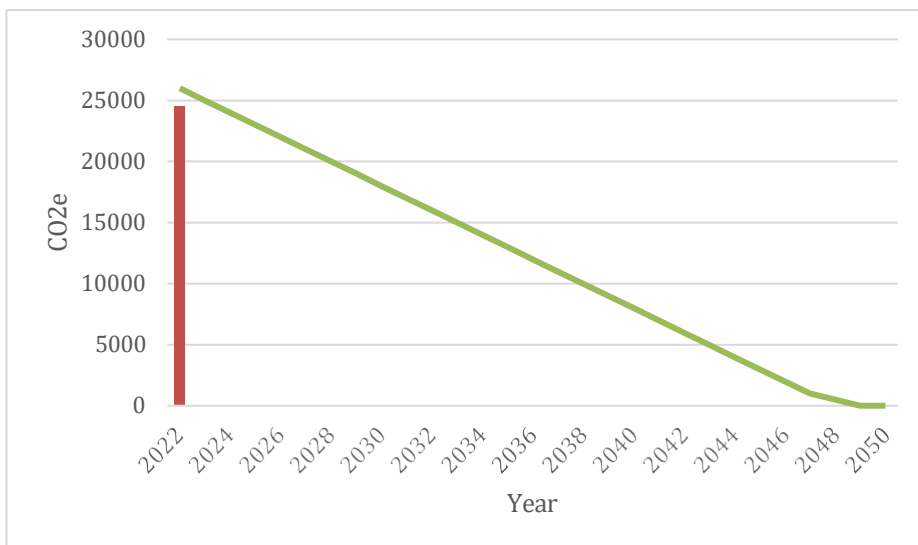

Emissions reduction targets

In order work towards our target to achieving Net Zero, we have adopted the following carbon reduction targets.

We project that carbon emissions will decrease over the next five years to 22,000kg CO2e by 2027. This is a reduction of 12%

Completed Carbon Reduction Initiatives

The following environmental management measures and projects have been completed or implemented since the 2022 baseline. The carbon emission reduction achieved by these schemes equate to zero tCO₂e, a 0%ge reduction against the 2022 baseline and the measures will be in effect when performing the contract.

Formal activity in this area began in 2022 with the formation of our Environment Group and this first report combined with senior level support for the overall plans and targets is a significant step forward for the organisation.

2022 is the baseline reporting year for The Skills Centre from which we will measure the impact of our environmental management measures and projects.

The proposed carbon reduction projects The Skills Centre have planned in 2022 and beyond include

- Improve waste management programme
- Reduce energy consumption programme
- Wide ranging staff engagement and information strategy
- Review of travel guidance
- Implementation of improved environmental criteria as part of internal procurement policy

A primary focus for 2023 is to develop more accurate measures for scope 3, particularly working with our core suppliers to understand upstream and downstream carbon emissions.

Declaration and Sign Off

This Carbon Reduction Plan has been completed in accordance with PPN 06/21 and associated guidance and reporting standard for Carbon Reduction Plans.

Emissions have been reported and recorded in accordance with the published reporting standard for Carbon Reduction Plans and the GHG Reporting Protocol corporate standard¹ and uses the appropriate Government emission conversion factors for greenhouse gas company reporting².

Scope 1 and Scope 2 emissions have been reported in accordance with SECR requirements, and the required subset of Scope 3 emissions have been reported in accordance with the published reporting standard for Carbon Reduction Plans and the Corporate Value Chain (Scope 3) Standard³.

This Carbon Reduction Plan has been reviewed and signed off by the executive board of directors.
